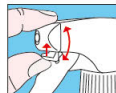

HG weathered wood restorer

New teak or other hardwood garden furniture always looks wonderful because of its natural warm finish. However, once furniture has been out in all kinds of weather for a season, this warmth has been replaced by a tired grey sheen. Sanding down the furniture to remove this dullness is an unpleasant task. This is why we have developed **HG weathered wood restorer**. **HG weathered wood restorer** cleans and restores faded/grey hardwood furniture in a single simple treatment to its original beauty. **HG weathered wood restorer** can also be applied to other wood types (e.g. maranti, mahogany, pine, etc.) as well as cane, rattan and bamboo furniture.

Directions for use: Remove the locking clip before use. Press the nozzle at the front side and turn a quarter. After the preparation (see attention), spray the surface to be treated with the **HG weathered wood restorer** (beware of spillage on clothes: will cause bleach stains!). Allow to penetrate for 10 minutes, you will see the wood loose its greyness. The loosened dirt can be removed using a brush or a sponge and lots of water; it is advisable to use a hose or watering-can for this. Do not use a pressure hose! Turn the nozzle a quarter backwards after use (blocking position).



Coverage: 2-3 garden chairs per 500 ml depending on the degree of dirt.

Attention: Place the furniture to be treated on a hardened surface (e.g. terrace or driveway) that has good drainage possibilities. Be careful on coloured tiles in case of possible bleaching! Do not use on coloured concrete tiles. **Transport and store cool, dark and in an upright position.** Before starting the treatment, cover all metal parts of the furniture to be treated. • Medical personnel can request the data sheet via +31 36 54 94 777 • The consumer's information sheet can be obtained via www.HG.eu

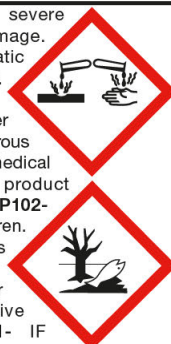
