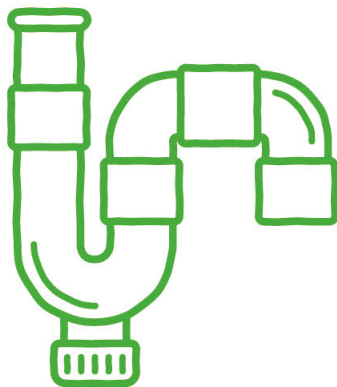

Ingredients such as allergens, parabens and chlorine are also excluded from the HG eco range. Packaging made of 100% recyclable materials. In brief: HG eco products are sustainable products, but with the familiar HG performance and effectiveness!

Instructions: Carefully pour 500 ml of *HG eco unblocker* down the blocked drain. Leave it to work for at least 5 minutes and rinse with plenty of water. In case of a stubborn blockage when the drain does not drain at all, let the sink or basin run full of warm water. Add 500 ml of HG eco unblocker to this water and leave it overnight. Next morning rinse it with hot water. As HG eco unblocker is heavier than water, it sinks through the water to the blockage. The combination of the product and the water pressure will remove the stubborn blockage.
