#### Directions:

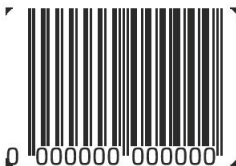
**For walls:** Apply a few drops of this product to a damp (bathroom) sponge and clean the surface, then rinse or wipe off with a damp cloth.

**For floors:** Dissolve 50 ml (half a cup) in half a bucket (5L) of lukewarm water. Then clean the floor with a wrung-out mop or floor cloth, regularly rinsing it in the cleaning solution. Do not rinse or mop dry, simply leave the floor to dry on its own.

**Attention: Transport and store the bottle upright.** To protect bathrooms and shower partitions against moisture, dirt and stains, we advise the use of *HG natural stone protector (product 35)*.
