HG patio-tile cleaner is a very concentrated detergent that has been developed especially for cleaning dirty and stained concrete, slabs and paving stones.

Directions for use: First use a broom to remove as much of the loose dirt as possible. Thoroughly wet the dirty stones and particularly the joints with water. Brush puddles away. Wear rubber/plastic gloves. Pour the bottle into a bucket and add 4 litres of water. Use a scrubbing brush to spread the liquid and scrub. Leave to work for a few minutes. After that, scrub again. Prevent the liquid from drying out. Then rinse off the stones with plenty of water. Once dissolved in water (1:4) the product is not harmful to flowers and plants. In order to protect against regrowth of green deposits after cleaning with *HG patio-tile cleaner*, we recommend treating the surface with *HG algae and mould remover*.

Coverage: ± 25 m².

Transport and store the bottle upright.
