## HG perspiration stain remover

Perspiration and deodorant can cause persistent yellow stains in fabrics. These stains cannot be removed with ordinary detergents or stain removers. *HG perspiration stain remover* is THE effective pre-treatment for removing such stains and is suitable for white and coloured fabrics. Using this product before every wash also prevents these types of stains.

**Directions for use:** Turn the nozzle on the front a quarter turn. **Spray a liberal amount of liquid on the stains and leave to absorb for 30 minutes. Prevent the liquid from drying out by spraying on a little more.** Prevent the liquid from coming into contact with other materials or surfaces, because this can cause damage and/or stains. Put the treated fabric in the washing machine and wash it as usual with the recommended amount of main detergent at max 60°C. Always comply with the care label. Repeat the treatment if necessary. Turn the nozzle a quarter-turn after use (OFF).

**Attention:** Transport and store the bottle upright. Only use on colour-fast fabrics, in case of doubt test the product in an inconspicuous place. Avoid direct contact with metal elements (zips, buttons). If necessary, with thicker fabrics for example, spray the fabric on both sides for a more intensive treatment. **If you have extremely dark stains that have been in the fabric for a long time, spray the fabric liberally on both sides and rub together.** Make sure you wear household gloves. Continue to repeat this treatment


