Drains can become smelly because of deposits in the pipes and down the drain. **HG drain odour remover** thoroughly removes the deposits that cause this odour and the drains smell fresh again. 1 bottle is sufficient for 6 treatments.

**Directions for use:** Rinse the drain first with hot water. Pour 80 gr (8 caps) granules straight down the sink and into the drain pipes. Leave it to work for 30 minutes and then rinse thoroughly with plenty of hot water.

**Attention:** Use hot water immediately to rinse any remnants from the plug, the waste grid or the sink. Don't use too much water, because that rinses the product from the trap and reduces its effectiveness. If this product is spilled, remove it immediately with plenty of water. When the dishwasher is connected to the kitchen drain, we recommend you do not use this product during or just before using the dishwasher. This would make using this product less effective, because the granules would be washed away.
