## HG algae and mould remover

*HG algae and mould remover* is a surface Biocide for amateur use for the control of fungi, mould, lichen, mildew and algae on external surfaces such as masonry, tiles, roofs, walls, patios, paths, fences, boats, caravans etc. *HG algae and mould remover* also slows down regrowth.

**Directions for use:** *HG algae and mould remover* should be diluted with 1:20 parts of water (one bottle equals two buckets of water). Pour with a watering-can over the area to be treated or apply with a brush or yard broom. Then leave the product to do all the work for at least 36 hours. After a few days the debris can be removed by hosing or brushing away. Do not use during wet weather. Do not pour directly on plants or grass. The effectiveness of *HG algae and mould remover* can be reduced if contaminants other than green deposit are present on the surface. The active ingredient also adheres to the other contaminants, which prevents it from fully penetrating into the green deposit. We recommend first using *HG patio-tile cleaner* to clean patios made of non-acid sensitive tiles such as gravel tiles, etc. and which are not contaminated only with green deposit. Use *HG tile cleaner extra strong (product 20)* for acid-sensitive surfaces such as hard stone/blue stone, marble, etc.

Keep pets away from treated areas that are still moist.

**Coverage:** 1 litre diluted for approx. 200 m<sup>2</sup>.

**Attention: Transport and store the bottle upright.** For the best result, do not use *HG algae and mould remover* at an outside temperature below 10°C. Do not pour the solution directly on grass and plants.

*HG algae and mould remover* becomes ineffective if it gets into contact with synthetic detergents. WASH HANDS AND EXPOSED SKIN before meals and after use. WASH ANY CONTAMINATION from skin or eyes immediately. Keep only in the original container. Keep container tightly closed. KEEP IN A SAFE PLACE. This product contains substances which are known to be hazardous to the environment. Do not contaminate ground, waterbodies or water-courses with chemicals or used container. Keep away from food, drink and animal feeding stuffs.

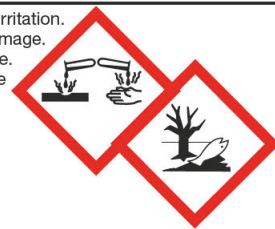
