In addition to the powerful water-repellent effect this product also prevents oil, grease and wine stains etc. After treatment with this product, those stains can be simply dabbed off of the surface with absorbent tissue paper. This product can be used on many materials such as sofas, clothing, shoes and bags.

Directions for use: Do not breathe spray. Only use this product in a properly ventilated area or outside. Before use first test the surface for colourfastness in an inconspicuous place. If the treated part is discoloured, do not treat the material with this product. The material that requires treatment must be clean and dry. If the material to be treated is already coated, this may reduce the performance of the product. Hold the can upright and spray HG 4-in-1 protector for textiles and leather onto the surface in even strokes from a distance of approximately 20 cm. Using too much product (soaking) is to be avoided. After leaving to dry for an hour, the treated material is ready for use again and fully protected. To provide lasting protection, repeat the treatment from time to time.

Use: The content of the can is enough for approx. 3.5 m².
