HG stain away 3 - Directions for use: Test a small inconspicuous part of the material beforehand to check that it is colour-fast. Remove as much of the stain as possible beforehand. Allow the product to work in for 10-15 minutes in a small bowl containing the product. Then rub cloth to cloth and rinse off well with hot water. If necessary repeat the procedure and allow the liquid to dry. Place small stains on an absorption white surface, e.g. a white tissue, and dab up with a cloth dampened in the product. Then rinse off well with hot water. **Transport and store the bottle upright.**
