A completely invisible protection that does not alter the feel of the surface. Suitable for all expensive leather, especially porous types of leather such as suede and nubuck. Not only effectively water and dirt repellent, but even prevents troublesome oil and grease from causing staining. After treatment with *HG 4-in-1 protector for leather* accidents are no longer a problem because spillages remain on top of the leather ensuring that all types of marking can be easily wiped away with an absorbent tissue. Ideal for leather sofas, clothing, bags, shoes etc.

Directions for use: Avoid breathing spray. Use only outdoors or in a well-ventilated area. Test on an inconspicuous area of the leather beforehand to check for colour-fastness. Do not treat if the colour runs. The material to be treated should be clean and dry. Keep the can upright and spray evenly from a distance of about 20 cm onto the surface to be treated. Avoid excessive over application (saturation). After drying for about one hour the treated material will be perfectly protected and ready for use. For surfaces that are subject to wear, such as seats or arm rests, repeat the treatment once every 2 or 3 months. The contents of the can are sufficient for approx. 3.5 m² leather. For cleaning leather we recommend *HG deep cleaner for leather* and for maintaining leather *HG 4-in-1 leather cleaner*.

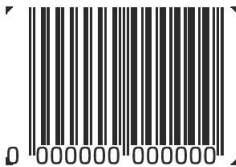
